My name is Lucia Bonova and I am a member of the Cabinet of executive vicepresident of the European Commission, Margrethe Vestager. I am contacting you as we are reflecting upon the current situation concerning the shortage of semiconductors in Europe and the steps we could take in that respect.

As automotive industry has been particularly affected by this situation we would be interested in engaging with stakehodlers to better understand the situation and the needs of the industry.

In particular, we would be interested to discuss the following issues:
