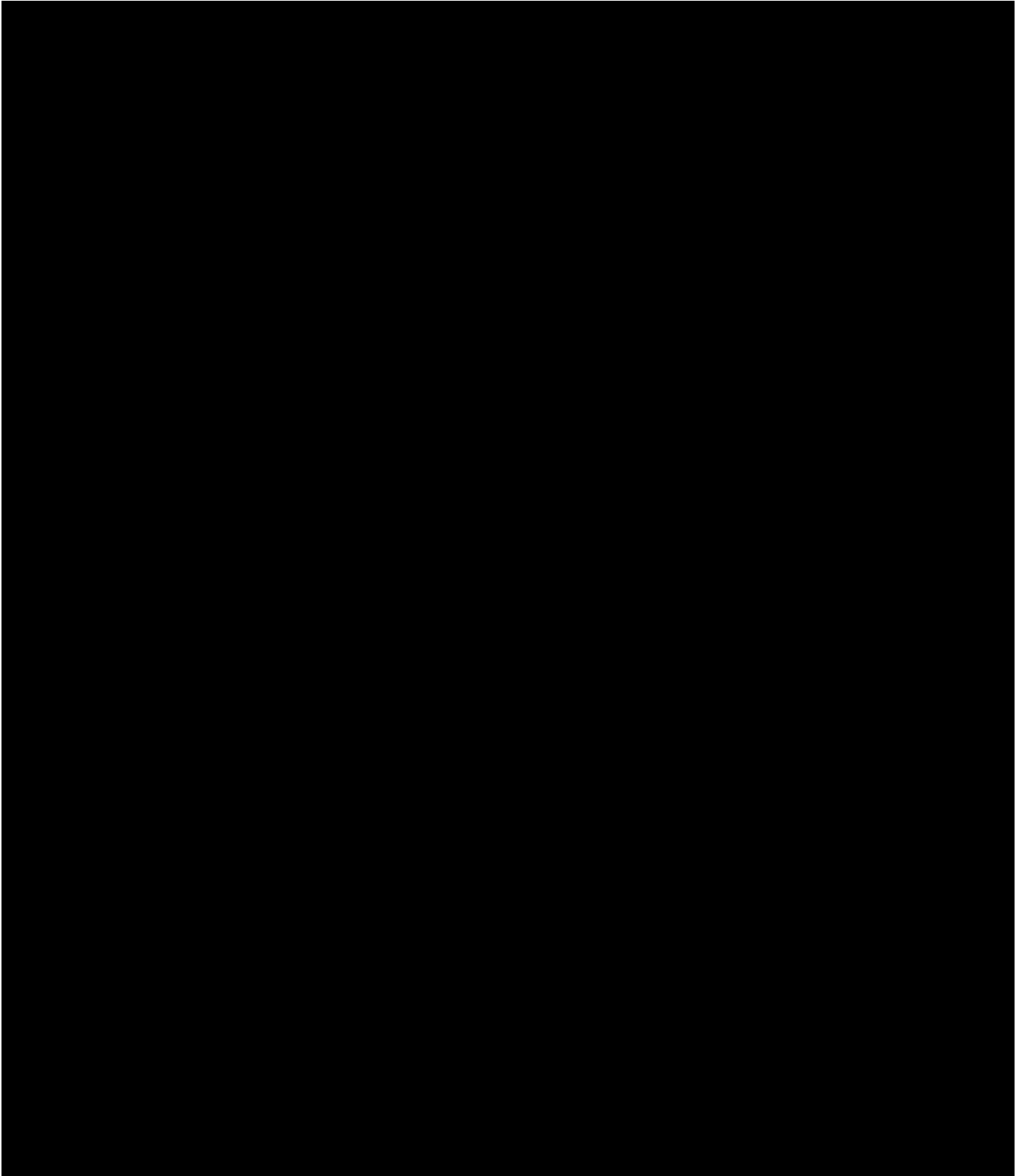
B. STANDARD TERMS

17. Data Protection

- a.
