- Comparison of the Efficacy of Five Front-of-Pack Nutrition Labels in Helping the Brazilian Consumer Make a Healthier Choice. This is the published version of the Brazilian consumer study which we previously shared in June.
- Unilever's response to request for changes to Nutri-Score algorithm issued by Countries Officially Engaged in Nutri Score (COEN). You may be aware that in August this year, authorities of several EU Member States that have recommended the Nutri-Score front-of-pack nutrition labelling scheme in their countries, asked stakeholders to provide feedback on the request for changes to the algorithm.
