Looking forward to welcoming you on the day of our online event, we remain at your disposal for any further information or clarification.

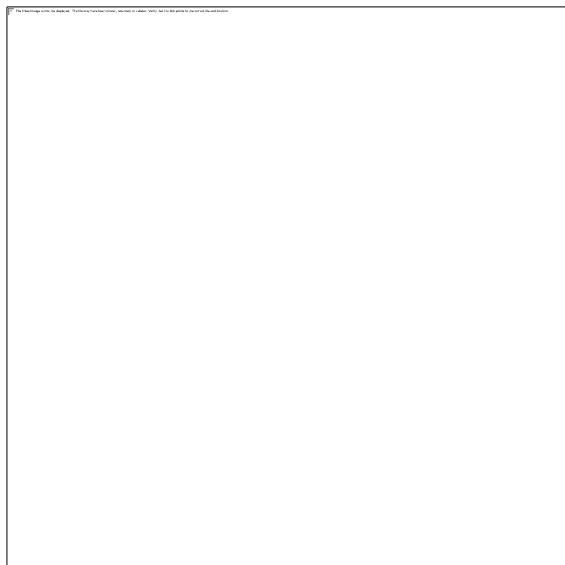

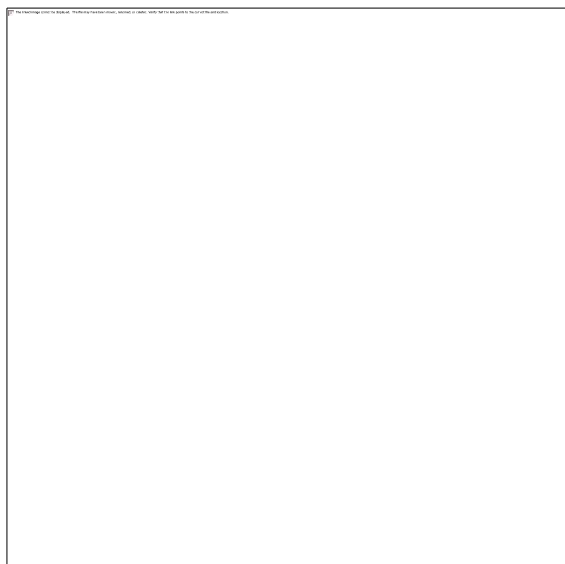
