

Dear Henrik,

Thank you again for the very insightful and interesting discussion we had two weeks ago. I thoroughly enjoyed it and learned a lot from it. I would greatly appreciate it if we had the chance to continue these fruitful exchanges!

One topic is actually truly worrying us short term: the slot rules for coming winter. The continued effects of Corona crisis on global travel and a slowed down recovery due to effects of the terrible war in Ukraine (especially energy prices) bear the risk of creating a considerable impact on demand to levels clearly below 2019. If so, it would not make sense for us to ramp up the network up to 100% only to operate under the 80/20 rule. Therefore, a flexibility of applying lower usage rates would be highly appreciated from our point of view.

If you are interested, we could offer to come to Brussels, share our insights and exchange views. I think it could be a very interesting meeting. Just let us know if this would suit you!
