Subject: Your confirmatory application for access to documents under Regulation (EC) No 1049/2001 – GESTDEM 2022/4501

Dear Mr Vodopian,

I refer to your request of 30 September 2022, registered on the same day, in which you submitted a confirmatory application in accordance with Article 7(4) of Regulation (EC) No 1049/2001 regarding public access to European Parliament, Council and Commission documents¹ (hereinafter ‘Regulation (EC) No 1049/2001’).

Your confirmatory application was submitted in relation to your initial application of 7 August 2022 in which you requested access to:

‘Any information concerning the development of Council Regulations (EU) No 2022/334 and 2022/328 (amending the Regulation No 833/2014) and application of the restrictions introduced in the mentioned Regulations to student pilots and General Aviation pilots holding Russian citizenship and either an EU residence permit or dual citizenship of Russia and the EU, including (but not limited to) copies of any correspondence, written communications, operational conclusions, lines to take, briefings, presentations and notes of telephone conversations or meetings concerning the development and/or application of the above Regulations on the mentioned matter’

The processing of your initial application was assigned to the Directorate-General for Financial Stability, Financial Services and Capital Markets Union. In the initial reply of 22

September 2022, the Directorate-General for Financial Stability, Financial Services and Capital Markets Union has granted full access to three documents.

In your confirmatory application, you contested the fact that your application was attributed to the Directorate-General for Financial Stability, Financial Services and Capital Markets Union rather than to the Directorate-General for Transport and Mobility.

In the meantime, please note that a new initial request has been registered and attributed to the Directorate-General for Transport and Mobility under registration number 2022-5636.

Taking into account that you have not contested the disclosure provided by the Directorate-General for Financial Stability, Financial Services and Capital Markets Union to the three documents, which were sent to you in response to your request Gestdem 2022-4501, the Secretariat-General will close your confirmatory application related to this request.

You remain entitled to submit a confirmatory application in accordance with Article 7(2) of Regulation (EC) No 1049/2001 in case you are unsatisfied with the reply provided to your request 2022-5636.
