I am contacting you on behalf of the Sustainable Biomass Program ([Error! Hyperlink reference not valid.](#)).

SBP is a voluntary certification system for woody biomass in the form of wood pellets and woodchips used in industrial, large-scale energy production. SBP is the only scheme that can be relied on to demonstrate compliance with the requirements in all the key biomass markets in Europe. In 2020, 76% of the industrial pellets consumed in the EU-28 were SBP-certified.

Discussions related to the use of forest biomass for energy production are taking centre stage as the Commission prepares the revision of the Renewable Energy Directive (REDII) as part of the 'Fit for 55' package. SBP would like to share their perspective on this topic from the angle of a certification system.
