Dear Mr Goetz,

You would recall that we met a few weeks ago; I was part of a joint delegation of airlines that met you and your team to talk about the airlines' ownership & control regime in the EU.

I am contacting you to explore the possibility of arranging a high level meeting between Commissioner Vălean and [REDACTED] IAG, [REDACTED].

We think it would be a great opportunity to have an open exchange of views on topics of common interest, related to aviation. [REDACTED] has met Commissioner Vălean in the past but it has been as part of joint sessions with other stakeholders. I'd also remark that [REDACTED] will be chairing Airlines for Europe, from March onwards. He will be in Brussels on 28 March and this could be a suitable date for him should Commissioner Vălean be available.

As a first step, and in preparation of the meeting, I'd like to propose that we meet at the end of January. I'll be in Brussels and have availability on the 24th and in the afternoon of the 25th.
