Disclosure of this information could undermine the protection of the commercial interests of that association (Art. 4.2 first indent).

11	06/05/2013	International Relations Committee	Partial	From the "Summary of MVH intervention": *thirty one words cannot be released as they contain EU's assessment of possible US position in the TTIP negotiations whose release could undermine the EU's relations with US and consequently undermine protection of international relations (Art. 4.1 (a) third indent). *Thirteen words have been withheld as they contain elements of the EU's strategy in relation to future EU investment agreements. Putting this information in the public domain would undermine EU's position while negotiating with third countries thus undermine the protection of the EU's international relations (Art. 4.1 (a) third indent and Art. 4.3). From the "Q&A" session: *twelve words cannot be released as they contain EU's assessment of US position in the TTIP negotiations whose release could undermine the EU's relations with US and consequently undermine protection of international relations (Art. 4.1 (a) third indent). *Eight words have been withheld for containing an assessment of Fertilizers Europe on the US energy policy. Its release could undermine the protection of the commercial interests (Art. 4.2 first indent). *One sentence cannot be released as it contains the EU's negotiating strategy. The release of that information could weaken our position in the ongoing TTIP negotiations and consequently undermine the EU's international relations (Art. 4.1 (a) third indent).
