Dear Ms Cann,

We refer to your e-mail dated 13 July 2015 and registered on 14 July 2015 under the above-mentioned reference number.

In your e-mail, you request "...copies of all other applications by former Commission President Barroso which seek Commission authorisation for new professional activities under the commissioner code of conduct, in particular as Visiting Professor at the Graduate Institute of International and Development Studies (Geneva); Visiting Professor at the University of Princeton (New Jersey); Visiting Professor at the University of Geneva (Switzerland); Visiting Professor at the Universidade Católica Portuguesa (Lisbon); and President Emeritus of the Teneo Leadership Institute at the University of Cornell (New York). I would further like to request any emails, correspondence and meeting notes which relate to these applications; all opinions from the ad hoc ethical committee on each case; and copies of the Commission's final decision in each case."

I have identified 5 documents falling within the scope of your request:

1. Letter of Mr Barroso to President Juncker of 08.01.2015 [Ref. Ares(2015)85587];
2. LS Consultation [Ref. Ares(2015)172683];
3. Commission Decision C(2015)273 of 19.01.2015;
4. PV(2015)2112 of 21.01.2015;
5. Letter of Ms Day to Mr Barroso of 22.01.2015 [Ref. Ares(2015) 253420];

You will find a detailed list enclosed.

1. PUBLIC DOCUMENTS

Document n° 3 contains the extract of the minutes of the Commission meeting in which the decision on Mr Barroso's post-mandate activities was adopted. Please note that the minutes are already available to the public and therefore, a copy is not enclosed.

2. CONCLUSIONS UNDER REGULATION 1049/2001

Following the examination of your request and of the documents concerned, I am pleased to grant you:

- Full access to documents n° 3 and to the draft decision attached to document n° 2.
- Partial access to document n° 1 and to the cover e-mails accompanying document n° 2 and cover note to document n° 5.

You will find copies enclosed.

Please note that the document attached to document n° 5 corresponds to document n° 3.

The reasons for the refusal of the deleted parts of document n° 1 and of the cover e-mails of documents n° 2 and the cover note to document n° 5 are set out below.

The deleted parts of the above-mentioned documents n°1 and n° 5 contain the e-mail and/or the postal address of the former Commissioner and for obvious reasons this is personal data covered by the exception provided for in Article 4 (1) (b) of Regulation 1049/2001. This is also the case of the deleted parts in the cover e-mails accompanying document n° 2, which contain the e-names and the e-mails of the Commission's officials in charge of the file. Disclosing this information would reveal personal data and may undermine the privacy of the concerned Commissioner as well as of Commission officials.

In its judgment in the *Bavarian Lager* case¹, the Court of Justice ruled that when a request is made for access to documents containing personal data, Regulation (EC) No. 45/2001² (hereinafter the 'Data Protection Regulation') becomes fully applicable.

The concerned documents contain elements which undoubtedly constitute personal data in the meaning of Article 2(a) of Regulation (EC) No 45/2001, as they reveal information about an identified or an identifiable person. According to Article 8(b) of the Data Protection Regulation, which is fully applicable in this case, personal data shall only be transferred to recipients if the recipient establishes the necessity of having the data

transferred and if there is no reason to assume that the data subject's legitimate interests might be prejudiced.³ Those two conditions are cumulative.⁴

I consider that in the present case the necessity of disclosing the aforementioned personal data to you has not been established in your request.

Consequently, access to personal data contained in the relevant parts of the above-mentioned documents has to be refused on the basis of the exception provided for in Article 4 (1) (b) of Regulation 1049/2001.

If you wish to appeal against this decision, you should write to the Commission Secretary-General at the address sg-acc-doc@ec.europa.eu. You have fifteen working days from receipt of this letter in which to appeal.
