

**MEMBER STATES' NOTIFICATIONS ON

Austria

Referring to the request from the chair of the Code of Conduct Group I would like to inform you that Austria has not enacted any new measures that could be harmful within the scope of the Code of Conduct in the year ending 31 January 2012.

Ireland

I can confirm that no measures have been enacted in Ireland in the year ending 31st January, 2012 that could potentially fall within the remit of the Code of Conduct Group.

Italy

Member States have been requested to submit, by 31 March 2012, written information on any new measures which potentially fall within the scope of the Code of Conduct and which have been enacted in the year ending 31 January 2012.

On this matter, I would like to inform you that Italy has not introduced any new measures which may be taken into consideration for the purposes of the Code of Conduct.

Latvia

In reply to the standstill notification request sent by the Chair of the Code of Conduct Group on 17 February 2012 I would like to confirm on behalf of the Ministry of Finance of the Republic of Latvia that by the end of January 2012 Latvia has not introduced any new measure which potentially falls within the scope of the Code of Conduct (standstill).

Lithuania

Regarding standstill please also note that no new measures which could potentially fall within the scope of the Code have been enacted in the year to end-January 2012.

Luxembourg

Luxembourg has not introduced any new measures which potentially fall within the scope of the Code of Conduct Group and which have been enacted in the year ending 31 January 2011.

Malta

Reference is being made to the email from the General Secretariat of the Council of the EU, dated 17 February 2012, on monitoring standstill and implementation of rollback the following is the reply of the Maltese Government.

With regard to the work on monitoring standstill, Malta has no new measures which potentially fall within the scope of the Code and which have been enacted in the year ending 31 January 2012 to report.

Netherlands

In the year ending 31 January 2012, The Netherlands has not enacted any new measures that are potentially harmful under the criteria of the Code of Conduct. Nor is the Netherlands aware that any such measures have been enacted in the fiscal autonomous other countries within the Kingdom of the Netherlands (Aruba, Curaçao and St. Maarten).

Poland

I refer to the request from the Chair of the Code of Conduct Group to notify that Poland has not introduced any measures inconsistent with stand-still principle.

Portugal

On behalf of the Portuguese delegation to the Code of Conduct Group, I am pleased to inform that during the year ending on the 31 January 2012, there were not adopted any new measures which potentially fall within the scope of the Code of Conduct.

Romania

On behalf of the Romanian delegation to the Code of Conduct Group we are pleased to inform you that during the year ending January 2012 no new measures which potentially fall within the scope of the Code have been taken.

Slovak Republic
