Subject: Your application for access to documents – Ref /GestDem No 2015/6589

Dear Ms Cann,

I refer to your e-mail dated 14 December 2015 and registered on 15 December 2015 by which you make a request for access to documents under the above mentioned reference number.

Your application concerns "all documents which relate to any applications made under the Staff Regulations for authorisation for post-employment activities by Paul Weissenberg". In particular, you request "a note of all Mr Weissenberg's job titles at the Commission including dates held; copies of any application(s) that he has made under the Staff Regulations to undertake a new professional activity including dates made and dates authorised; and all documents (correspondence, emails, meeting notes etc) related to the authorisation of the new role or roles".

I have examined your request under the provisions of Regulation (EC) No 1049/2001 of the European Parliament and of the Council of 30 May 2001 regarding public access to European Parliament, Council and Commission documents.

The documents identified are one application form submitted by Mr Weissenberg in the framework of Article 16 of the Staff Regulations and the related decision from the Appointing Authority. I have also identified e-mail exchanges which took place between 18 September 2014 and 30 October 2014 within Commission services or between Commission services and Mr Weissenberg, pertaining to the underlying internal procedures concerning that request for authorisation.

The documents you requested contain personal data relating to the past and present occupational activities of Mr Weissenberg. It is the Commission's obligation to ensure that the privacy and the integrity of the EU staff member concerned, also in his professional capacity, are correctly protected. This is why I consider that the exception foreseen in Article 4(1)(b) of Regulation No 1049/2001 applies.

As for the e-mail exchanges between the Commission services and Mr Weissenberg, the second subparagraph of Article 4(3) of Regulation (EC) No 1049/2001 applies. In addition, in the absence of an overriding public interest, the exception to the right of access cannot be waived.

While I have also considered the possibility of granting partial access on the basis of Article 4(6) of Regulation (EC) N° 1049/2001, I have concluded that this would equally undermine the protection of personal data.

Against this background, I can nevertheless provide you with the following general information on the process to which your request relates.

Mr Weissenberg submitted a declaration of intention to engage in an occupational activity after leaving the Commission (Article 16 of the Staff Regulations), dated 17 September 2014 and registered on 18 September 2014, relating to the authorisation to engage in a remunerated occupational activity as an advisor to the Chief Executive Officer at Kreditanstalt für Wiederaufbau (KfW) Bankengruppe, in Germany.

Following the general rules concerning the consultation process for this type of request, the Appointing Authority gave its approval on 29 October 2014 to carry out this activity as it did not lead to a conflict with the legitimate interests of the Institution. Mr Weissenberg's commitment to neither represent KfW in Brussels or to do any lobbying for it was acknowledged. In conformity with the third paragraph of Article 16 of the Staff Regulations, Mr Weissenberg was also reminded that during the 12 months after leaving the service, he should not engage in any lobbying or advocacy vis-à-vis staff of the Commission on matters for which he had been responsible during the last three years in the service.

Furthermore I can provide you with some information on the last posts held by Mr Weissenberg covering the period which was assessed as regards any potential conflict of interest. In the period from 1/02/2011 to 31/08/2014, Mr Weissenberg was Deputy Director-General in charge of Space in DG ENTR and from 1/02/2011 to 31/03/2011 and from 1/10/2012 to 15/10/2013 Mr Weissenberg was acting Director in charge of Space in DG ENTR.

I would like to remind you that Corporate Europe Observatory remains subject to the provisions implementing Directive 95/46/EC¹ on the protection of individuals with regard to the processing of personal data according to which personal data must, *inter alia*, be processed fairly and lawfully and subject to the unambiguous consent of the data subject concerned.

In accordance with Article 7(2) of Regulation (EC) No 1049/2001, you are entitled to make a confirmatory application requesting the Commission to review this position.
