Dear Margaret

I already sent you the summary of the official position of the Romanian National Authority for

the Protection of the Rights of the Children and Adoption - ANPDCA (see my email of

30.10.2014). I attach to this email the original official answer (in Romanian) to our questions received from

the ANPDCA (answer that was summarised in the abovementioned email).

In the second letter addressed to the Managing Authority (ARES(2014)3832871 of 18/11/2014)

we have not requested for a specific answer, but only to monitor, during the implementation

phase of the project, the sensitive issues mentioned in that letter.

The beneficiary (ANPDCA) sent the first request for reimbursement, amounting for EUR 12,000,

in October 2014. This request was approved by the Managing Authority on the 16 of January

2015, but the payment to ANPDCA is not yet done.

There is no other request for reimbursement since then.

So, according to the financial progress of the implementation, it appears that there is not much

to be seen for the moment regarding this project.

However, we have send a new email to the head of the Managing Authority, asking what is the

actual implementation status of the project and if they can tell us something new about the

issues mentioned in our letter of 18/11/2014.

If the Managing Authority is not replying on time to our email, we will have the opportunity to

discuss about this project on the spot, as we will go on mission in Romania on 25 February.

However, I do not expect that neither the Managing Authority nor the Implementing Body

(which is the Ministry of Information Society) has sufficient expertise in child adoption issues

(they probably rely on ANPDCA on this).

I remain available should you have any additional questions.
