Dear Mr Šefčovič,

Europe: Shaken and Stirred?

European citizens are paying close attention to the leadership at the helm of the European Union as they tackle the migrant crisis. The United Nations estimates indicate that over one million people have entered Europe with the intention of claiming asylum. On a global level, UNHCR has stated that the number of forcibly displaced people reached almost 60 million in 2015, an increase of some 40% since 2014. The EU member states now have an opportunity to strengthen their collaboration and solve the refugee question with consistency. Will they succeed in overcoming this challenge? At the same time, a key factor shaping Europe's political future in the decades to come is the referendum on the UK's membership of the EU.

In relation to growth, the European Investment Plan aims to unlock public and private investments in the real economy of at least € 315 billion over the next two years which will - hopefully - break the vicious cycle of continued low growth and high unemployment in Europe. How can the plan live up to Europe's expectations and boost growth?

On the economic forefront, we are witnessing EU member states breaking away from economic stagnation and emerging stronger from the crisis. Following Ireland and Portugal, Cyprus is the third Eurozone country to leave the international bailout program this year.

Without a doubt, 2016 is set to be crucial for Greece's future as the country still faces many challenges to stabilize its economy, maintain the momentum of structural reforms and return to the path of competitiveness and growth after signing a revised programme with its creditors. What are the government's policy priorities for the next coming months and what role will the newly elected opposition leader play in Greece's political arena?


