Thank you very much for the fruitful exchange we had with you over dinner in Luxembourg earlier this month. As you suggested, we have prepared 10 one-page notes on our priorities for the post-2020 regulatory framework.

The 1st note shows how wind energy contributes to **jobs and growth** in the EU and how we can help make Europe no. 1 in renewables.
