I refer to your exchange of mails with DG ENV ACCESS DOCUMENTS Team, and in particular to the last one of 5 August 2016 in which you accepted the proposals made by this team on how to deal with your request for access to documents. You application was registered under the above mentioned reference number. The initial deadline expiring on 30 August 2016 was extended to 20 September by a letter of 18 August 2016.

Please note that, unless stated otherwise below, no formal minutes were done for these meetings as they were more of courtesy matter.

As for files falling under the Energy Union Strategy, considering that these files are all under the lead of either DG ENER, CLIMA or the Secretariat General, these services are the ones who convene meetings with stakeholders or other Commission services.
