
Draft agenda - trilogue on organic farming (T18)

I – Confirmation of the consolidated text (agreed parts in document 10460/17):

Confirmation by the trilogue that the square brackets can be removed from the text, except for the points under II and III of the agenda which are still open and any other point indicated by the Institutions



II - Remaining open political issues :

- 1. Non-authorised substances (Article XX, 20a and 20b) :- Decision to be taken on:
 - Articles XX and 20a
 - Article 20b(7) and (9)
- 2. Greenhouses (Annex I, part I, 1.1.d and deletion of Article 10(5): Decision to be taken on
 - Annex II, Part I, point 1.1d; [See SCA Room document n°2]

- 3. Seeds: decision to be taken on the following remaining points:
 - Definition of organic variety in Article 3(6e)(iii) and (iv).
 - Article 3a objectives, Indent 10 (organic varieties)
 - Article 10a (1) and (2)

 - Article 19a (1)
 - Article 21(3), last paragraph (deletion to be confirmed)
- 4. Databases (Article 19a): confirmation of the compromise as it stands in the consolidated text.

- 5. End of derogations (Article 35). Decision to be taken on the following points (See SCA Room document 2):
 - para 1, first sub para: reference to 4.1.2.1 (db) juveniles.
 - para 1, second sub para : reference to 'seeds' as regards
 - para 2: scope of the report:
 - all content of para 4.
