Dear Madame Commissioner, Dear Mr. Commissioner,

I feel honored to greet you with cordiality and to assure you of my entire appreciation.

As a follow-up to your letter of 04.04.2017, in which you asked for information on the application of double quality standards to food and food products, as well as the accomplishment of a comparative study, I replied to you on April 13 2017, communicating the measures taken until that moment, under my co-ordination as Minister of Agriculture and Rural Development in Romania, as well as the measures to be taken in order to carry out a comparative study.

According to those released on April 13, "after the accomplishment of comparative tests, we will return with additional information", which is the reason I am addressing you herewith.

On 07.04.2017, we addressed to our counterparts from five EU Member States: Belgium, The Netherlands, Germany, France and Austría a letter of request, on which we expressed our intention to send teams of Romanian specialists that will travel to these countries in order to identify and collect food products, which will become the basis of a comparative study.

Following these letters, we received positive reactions from our counterparts in Belgium, Germany and The Netherlands, on 08.06.2017, 12.06.2017 and 13.06.2017.

From 19 to 26 June 2017, a joint team of specialists in food, health and food safety, consumer's protection and European Affairs, took part in the identification and selection of food products in Maastricht -The Netherlands, Aachen -Germany and Brussels -Belgium.

During this action plan, were selected 29 samples from Belgium, the Netherlands and Germany, consisting in food products such as: meat preparations, milk preparations, canned fish, chocolate, as follows:

9 samples of cheese products

2 samples of butter

1 sample of cream

3 samples of fish cans

1 sample of chocolate

7 samples of ham

3 samples of sausages/ Frankfurters

1 sample of small sausages

2 samples of liver pate

Mrs.Elżbieta Bieńkowska , European Commissioner for industry and domestic market Mrs. Věra Jourová, European Commissioner for justice, consumer and gender equality Mr. Vytenis Andriukaitis, European Commissioner for health and food safety On 26.06.2017, the samples collected from Belgium, The Netherlands and Germany were handed over in safe conditions to the Institute of Hygiene and Public Veterinary Health Bucharest, institute coordinated by The National Sanitary Veterinary and Food Safety Authority (ANSVSA), in order to make the following analysis:

- physico-chemical analysis for meat, milk, fish, chocolate;
- the presence of fats of vegetable origin in milk and milk products.

On June 28-30 2017, immediately after collecting the samples from Belgium, The Netherlands and Germany, the teams organized and carried out the action of identifying and sampling the 29 identical products in the commercial networks of our country, according to the legal procedures in force, the samples being sent to the Institute of Hygiene and Public Veterinary Health Bucharest - ANSVSA.

Laboratory analyzes revealed differences in 9 samples, according to the following parameters: percentage of fat, protein percentage, energy value.

This topic is of particular interest, the public opinion in Romania showing a strong and constant pressure in order to clarify the issue of the double standard, being interested in the reaction of the institutions, producers and traders.

Wishing to respond to the legitimate interest of consumers, as Minister of Agriculture and Rural Development, we held a press conference on 26 July a.m.

Thus, together with the other institutions involved, I have presented the status of the actions undertaken and the results of the comparative laboratory analyzes, stating that the information I have provided can not be considered complete, as long as the action can be challenged, in the absence of a legal framework in this area.

In the letter no.277630 of April 13, 2017, we state "because the European Union currently has no legal instruments, procedures to determine the double standard of quality, we consider it appropriate to draft or supplement the Community legal framework on these issues".

Following the evolution of the debate within the European Union on this subject, they reconfirm my conviction that there are currently no procedural, methodological and legal tools for testing food products, which is why I believe that it is necessary to establish unitary rules for the sampling, analysis and interpretation of the results, in order for the Member States to implement a solid, common and efficient methodology.

I believe that this issue should be approached as a priority issue and this is the reason why I am at your disposal with any information and expertise in this area, in order to achieve the European common framework, so that Member States can respond efficiently to the issue of the double standard.

We attach to this letter the document that presents the analytical results of the comparative study on the products examined at which were found certain differences (Document signed by the heads of institutions involved and it's translation).

Thanking you for your cooperation, I assure you, Madam / Commissioner, of European respect and high appreciation.
