Dear Members of the SGC Gas Regional Group,

Thank you for your participation in the Regional Group meeting held on 29 June 2017.

Please note that today we uploaded on CIRCA BC **the results of the PCI assessment process** carried out according to the general criteria and the aggregated contribution to the specific criteria laid down in the TEN-E Regulation. The document "SGC results" was uploaded in folder "SGC Gas" (number "07"), subfolder "2017 06 29 RG Meeting".

The results uploaded on CIRCA BC are those presented at the SGC RG meeting of 29 June 2017. However, following the concerns expressed by some of the Members about the commercially sensitive aspects of the information, the attached document does not provide the scores. Project promoters may contact the Commission for information on the scores of their project(s).

In this context I would like to draw your attention to the fact that the "SGC Gas" folder on CIRCA BC is open only to the Members of the SGC RG, and thus the information published there shall not be disclosed to any third parties. I also would like to kindly remind you that according to Article 4(4) of the TEN-E Regulation, the ranking of PCI candidates is to be used only during the PCI identification process, and that neither the (final) regional lists, nor the Union list of PCIs shall contain any ranking.

Finally, we have been informed by ACER that the final version of the **NRAs opinions on the PCI candidates** will be made available to us on Monday, 10 July. We will upload the NRAs' opinion on CIRCA BC (subfolder "2017 06 29 RG Meeting") immediately after the receipt of the document.
