**Subject: Request for access to documents – GESTDEM No. 2018/3214**

Dear Mr Teffer,

Thank you for your e-mail of 12 June 2018 which was registered at the Internal Market, Industry, Entrepreneurship and SMEs Directorate-General of the European Commission on 13 June 2018, requesting access to documents under Regulation (EC) No 1049/2001 regarding public access to European Parliament, Council and Commission documents (OJ L145, 31 May 2001, page 43 and following).

### **1. SCOPE OF YOUR REQUEST**

Your e-mail requested access to documents as follows:

*"All documents - including but not limited to emails, papers, and minutes - created by and/or sent to the European Commission about Item 02 03 77 07 — Pilot project — Independent on-road RDE testing to ensure broad information and transparency for better market surveillance".*

### **2. DESCRIPTION OF DOCUMENTS IDENTIFIED**

We have identified six documents that either fully or partially match the scope of your request. The list of these documents is in annex. Please note that four of the documents (numbers 3-6) contain large sections of text which falls outside the scope of your request. These sections have been redacted from the documents.

### **3. DISCLOSURE OF SIX DOCUMENTS**

All six documents are disclosed. Documents 2-6 originate from the European Commission. You may reuse the documents free of charge for non-commercial and commercial purposes provided that the source is acknowledged, and that you do not distort the original meaning

or message of the documents. Please note that the Commission does not assume liability stemming from the reuse<sup>1</sup>.

Document 1 originates from a third party. I can confirm that DG Internal Market, Industry, Entrepreneurship and SMEs has consulted according to Article 4, paragraph 4 of Regulation 1049/2001 the third party with a view to assessing whether an exception in paragraph 1 or 2 is applicable, and has obtained their permission to release the document.

Please note that the document received from a third party is disclosed for information only and cannot be re-used without the agreement of the originator, who holds a copyright on it. The document does not reflect the position of the Commission and cannot be quoted as such.

The documents to which you have requested access contain personal data.

Pursuant to Article 4(1) (b) of Regulation (EC) No 1049/2001, access to a document has to be refused if its disclosure would undermine the protection of privacy and the integrity of the individual, in particular in accordance with Community legislation regarding the protection of personal data. The applicable legislation in this field is Regulation (EC) No 45/2001 of the European Parliament and of the Council of 18 December 2000 on the protection of individuals with regard to the processing of personal data by the Community institutions and bodies and on the free movement of such data<sup>2</sup>.

When access is requested to documents containing personal data, Regulation (EC) No 45/2001 becomes fully applicable<sup>3</sup>.

According to Article 8(b) of this Regulation, personal data shall only be transferred to recipients if they establish the necessity of having the data transferred to them and if there is no reason to assume that the legitimate rights of the persons concerned might be prejudiced.

We consider that, with the information available, the necessity of disclosing the aforementioned personal data to you has not been established and that it cannot be assumed that such disclosure would not prejudice the legitimate rights of the persons concerned. Therefore, we are disclosing the documents requested expunged from this personal data.

If you wish to receive these personal data, we invite you to provide us with arguments showing the need for having these personal data transferred to you and the absence of adverse effects to the legitimate rights of the persons whose personal data should be disclosed.

In case you would disagree with the assessment that the expunged data are personal data which can only be disclosed if such disclosure is legitimate under the rules of personal data
