Dear Mr President, dear Mr Juncker,  
The Association of German Banks (BdB) has welcomed the European Commission`s Roadmap for deepening Europe's Economic and Monetary Union (EMU). We agree with your analysis that after years of crises it is now time to take Europe's future into our own hands. Deepening the EMU is a means to an end: more jobs, growth, investment, social fairness and macroeconomic stability. Ideas as the installation of an Economic Monetary Fund and a European Minister of Economy and Finance, who could serve as Vice-President of the Commission and chair the Eurogroup, have to be discussed now and developed further.

The BdB President Hans-Walter Peters will be in Brussels on Wednesday, 10 January 2018, for political meetings to discuss political challenges at EU level. These include the debates regarding the future of the EU, but also the completion of the Banking Union as well as the ongoing Brexit negotiations. Mr Peters would very much appreciate if you could be available to meet with him on that day. During the past year, unfortunately, it did not prove possible to arrange an initial meeting.
