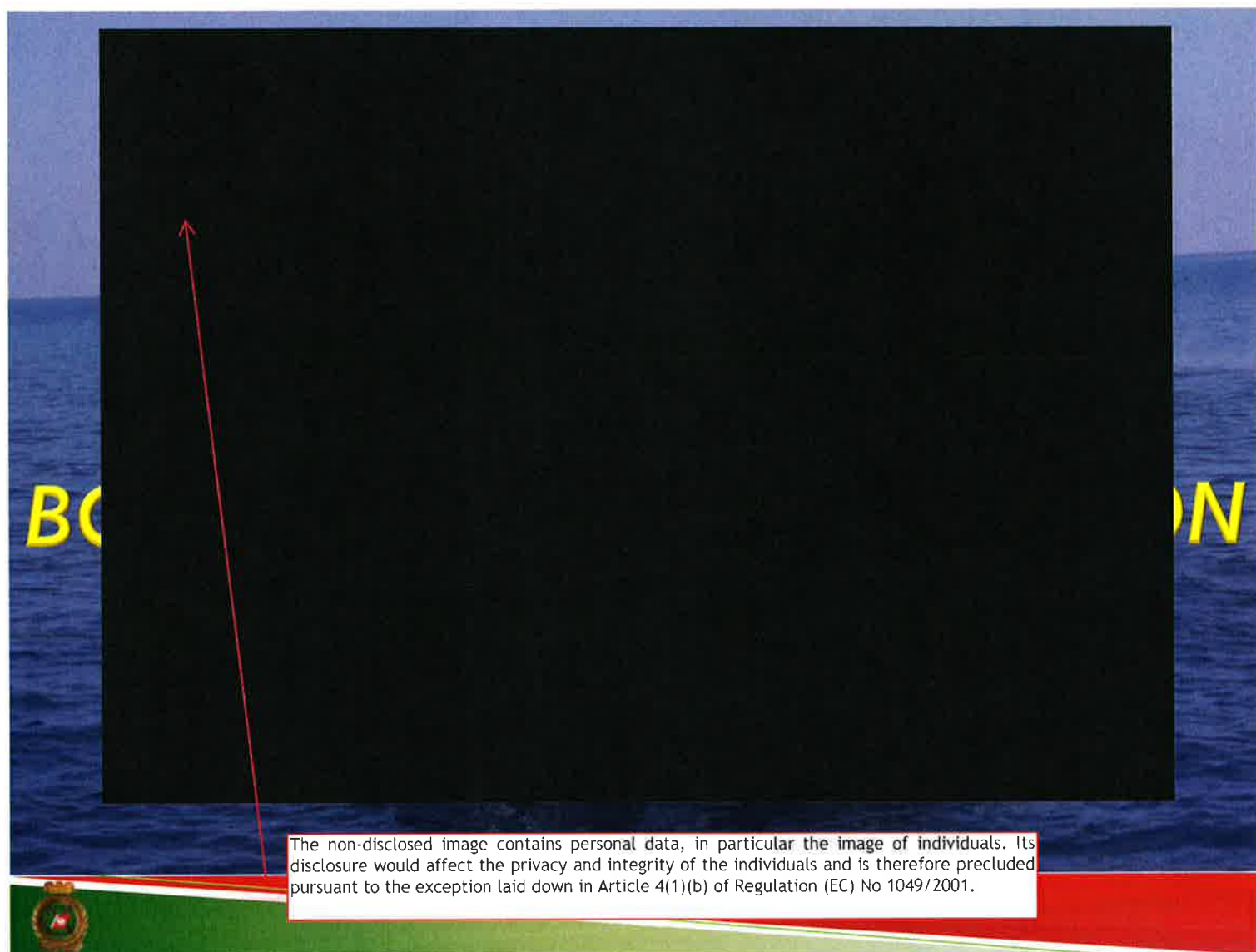

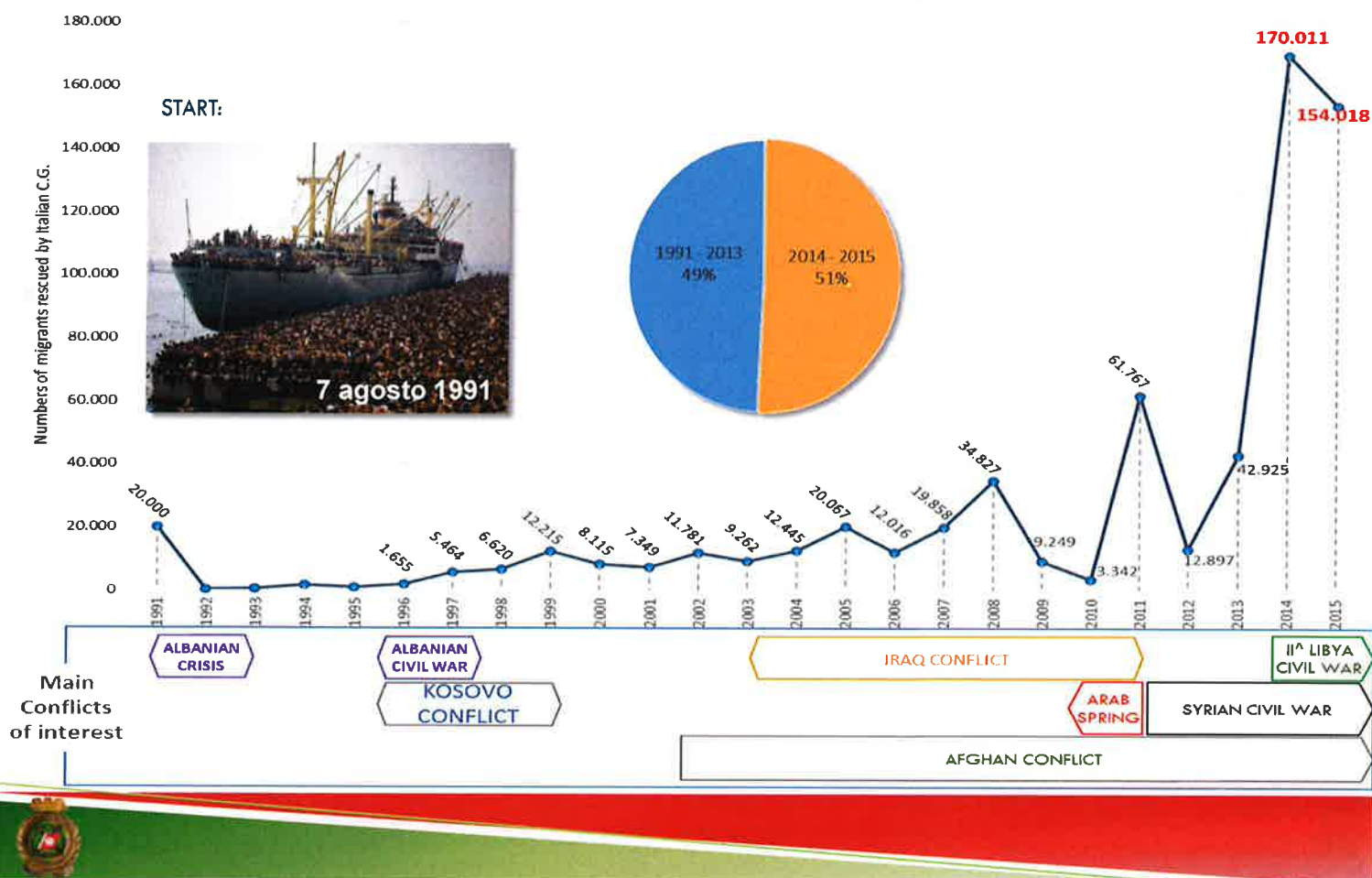

MIGRANTS RESCUED BY ITALIAN COAST GUARD 1991/2015 AND PUSH FACTORS

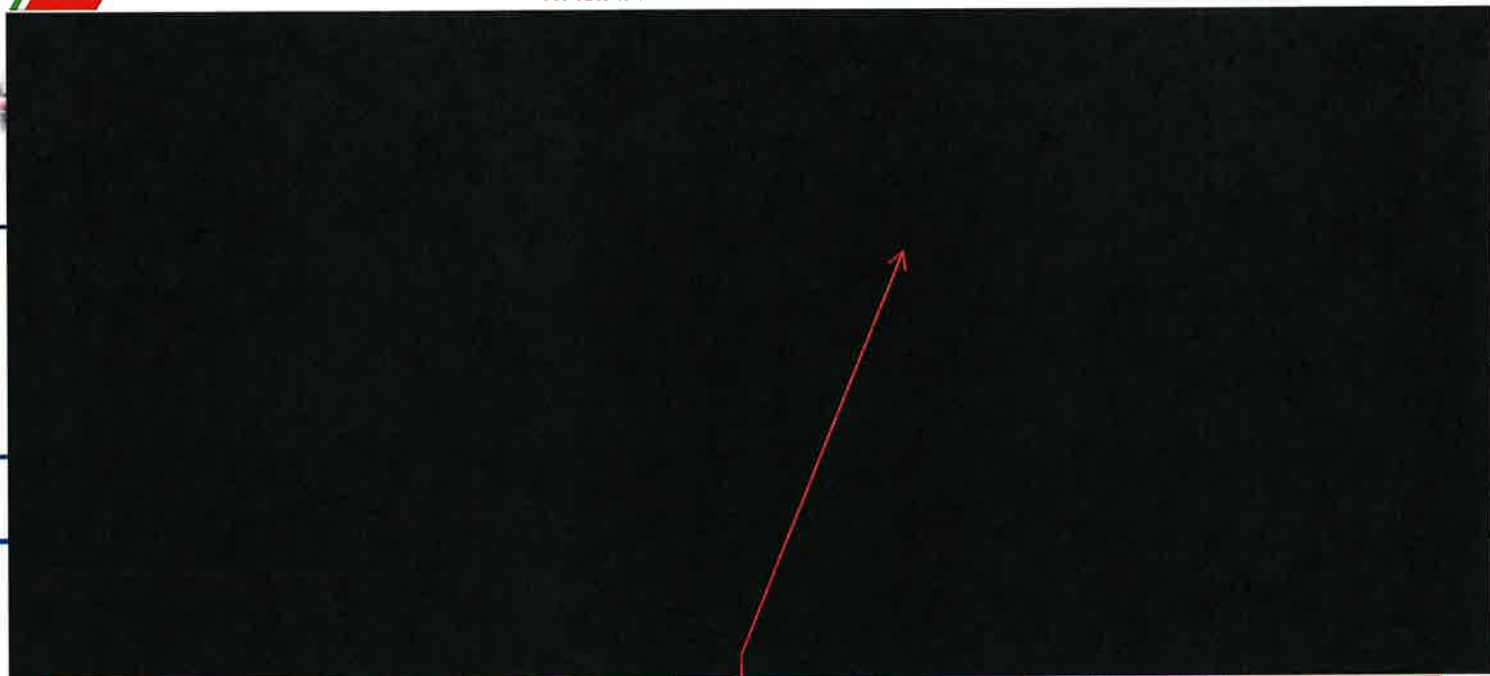
Total rescued from 1991 AL 2015: **638.612**





S.A.R. COORDINATION ACTIVITY

The non-disclosed images and text contain information regarding the operational area. Ongoing operations tend to cover similar operational areas as the operations of preceding years in the same geographical area. In this regard, disclosing images of the operational areas of previous years, would be tantamount to disclosing the current operational areas.

The result of this will only be to hamper the course of the ongoing operations, by depriving them of any strategy and element of surprise during border surveillance, ultimately obstructing their purpose to counter and prevent cross-border crime as well as prevent unauthorized border crossings.

In this light, the disclosure of such information would undermine the protection of the public interest as regards public security, in the sense of Article 4(1)(a) first indent of Regulation (EC) No 1049/2001.

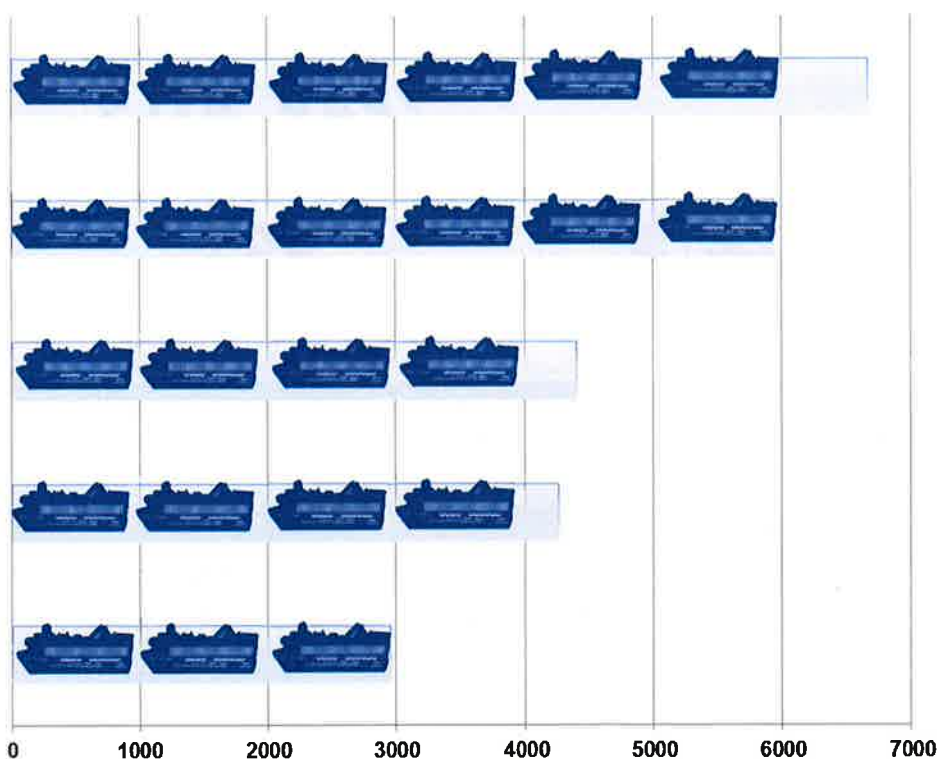
MAXIMUM NUMBER OF MIGRANTS TO BE DELIVERED IN A PLACE OF SAFETY

Therefore, public security will be affected. In light of the above the text is not disclosed pursuant to the exception laid down in the first indent of Article 4(1)(a) of Regulation No 1049/2001 relating to the protection of the public interest as regards public security.

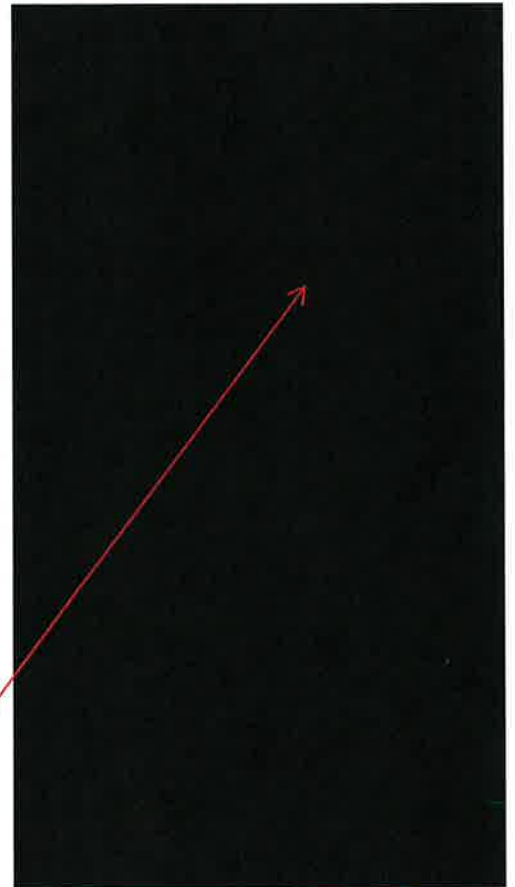
