First of all I would like to express my gratitude for your continued support and contribution to the joint maritime operations coordinated by Frontex Agency.

As a continuation of the operational activities in the Central Mediterraneanon 1 February 2015 Frontex has launched the Joint Operation EPN Triton 2015. Its key objective is to coordinate operational activities at the external sea borders of the Central Mediterranean region in order to control irregular migration flows towards the territory of the Member States of the EU and to tackle cross border crime. This operation aims at improving the border surveillance and border control through joint patrols with the assets provided by the Member States in the predefined areas.

This Evaluation and Planning Meeting will provide all participants with an excellent opportunity to share experiences and best practices from the previous operational activities in the framework of JO EPN Triton 2015.
