Since all these meetings were of a short, purely diplomatic courtesy nature, there were no reports, minutes or briefings, audio recordings, operational conclusions or presentations prepared before or after the meetings. Moreover, there are no emails that can be retrieved because the emails related to the practical arrangements of the meetings did not need to be registered in the Commission internal registration system Ares<sup>3</sup> and were automatically deleted by the system after a fixed period.

As specified in Article 2(3) of Regulation (EC) No 1049/2001<sup>4</sup>, the right of access as defined in that Regulation applies only to existing documents in the possession of the institution.
