8/ International cooperation, Article 50

9/ Cooperation with the EDPB IT User Subgroup

A. EDPB IT Platform, practical and procedural issues

The last meeting of the IT user subgroup was dedicated inter alia to the technical enhancement of the IMI system.

The secretariat informed the members that statistics on IMI are sent to the IT Users subgroup and to communication officers in SAs at the beginning of each month.

Since this September the Secretariat has access to the cooperation phase in order to provide assistance to users. The secretariat took the opportunity to highlight the most common problems.

B. Informal cooperation tool – exploring tools for gathering and sharing knowledge, experience and materials from the SAs

The EDPB Secretariat informed the group about an IT tool (Confluence) that could support the informal cooperation among the SAs (sharing information, using calendar, working on documents). The EDPB Secretariat presented this tool to the IT user subgroup on 11 October. The work on structure is ongoing and the supporting documents on 'How to better frame the informal cooperation phase' prepared by the Cooperation Subgroup was already taken into account.

The next step is that a demo of the system will be presented to IT user group in January. If the subgroup accepts this solution the system will be presented and discussed in all subgroups to gather further inputs to elaborate and adapt it to the needs.
