The FIN Patrol team was patrolling in Röszke with dog from GPS coordinates Text Removed - Justification 6. At 04:00 HRS they got information from the HUN Police that four irregular migrants have entered illegally in the HUN territory near the border sign Text Removed - Justification 6. Team went to the spot and dog handler, one member of team and HUN Police started to find tracks with the dog. Patrol found track and dog started tracing. At 04:30 HRS track went to the place with tight forest and bushes (GPS coordinates Text Removed - Justification 6) Suddenly a person jumped out from bushes. The dog reacted by biting which is natural defense reaction for service dogs. The dog handler immediately commanded to release. Due to long leash, darkness and very limited vision, dog handler didn't manage to see person before the dog. One arm and one leg of MNG woman was bitten by the patrol dog. The team gave first aid to the injured irregular migrant right after the incident.

Measures

The first aid for the injured irregular migrant (MNG female) was given immediately by FIN team on the spot. Straight after the incident the MNG woman was transported to the hospital in Szeged. Irregular migrant (MNG female) was treated in hospital and the doctors stated that the recovery is within 8 days, so the woman suffered light external injuries. The irregular migrant was released from the hospital after the medical treatment and was escorted to the transit zone by HUN Police. As already presented in SIR, sent on 11 September 2016, according to the HUN legislation and taking in to account that the case was accidental, the HUN Police did not initiate the criminal case. Service dog was used according HUN legislation.
