We refer to your application dated 2 September 2020 in which you make a request for access to: *“Council Regulation (EU) 2019/2197 of 19 December 2019 amending Regulation (EU) No 1387/2013 suspending the autonomous Common Customs Tariff duties on certain agricultural and industrial ...the table of tariff suspensions, which starts on page 5 of this document and ends on page 717”*, registered under the above mentioned reference number. This application, initially requested to DG TRADE, has been re-attributed to DG TAXUD.

Council Regulation (EU) No 1387/2013 is regularly amended (in January and July each year) to take into consideration new requests presented by the Member States.
