Thank you for your message regarding efforts to gather information on individual company indicators in combating illegal content online. We take this issue very seriously at Reddit and we are constantly evaluating our processes and policies to ensure that this content does not appear on Reddit.

Because Reddit is a much smaller and differently structured company than others you may be more familiar with, allow me to share some basic facts. At time of this writing, we have fewer than 400 employees in the entire company, and all of our offices are located within the United States, as are the majority of our users. We are also privately held. As a consequence, we do not disclose certain business-sensitive information, including information regarding specific content removals. While we may consider such disclosures in future iterations of our annual transparency report, we are not able to commit to them at this time. For these reasons, we regret that we are unable to provide a formal response to your questionnaire. Nevertheless, you may find useful information for your purposes in our most recent [Transparency Report](#).

We remain focused on these issues and ensuring that illegal content has no home on Reddit. As a next step on these matters, earlier this year we joined our industry peers in the terrorist content hashing consortium, and we are in the process of implementing that technology on our platform. We will continue to examine ways that we can combat the spread of terrorist content.
