INTRODUCTION (1/2)

























- In this report the term “End-Users” encompasses Pharmacies, Wholesalers and Healthcare Institutions.
- In this report, the term “MAH” encompasses both Original Pack Manufacturers and Parallel Distributors.
- The percentage of **connected End-Users** is presented per country.
 - >99 % is shown in Green
 - >95 % and < 99 % is shown Yellow
 - < 95 % is shown Red
- Out of these connected End-Users, the percentage of **End-Users actively scanning** is presented per country. “Actively scanning” means having scanned at least once a day for the past 30 days.
- The number of **active MAHs** reflects the number of MAHs having uploaded Product Master Data (PMD) at least once (since the 9th February) in the relevant NMVS out of the total number of MAHs expected to connect to the NMVS.
 - >99 % is shown in Green
 - >95 % and < 99 % is shown Yellow
 - < 95 % is shown Red
- Out of these active MAHs, the percentage of those having uploaded Product Pack Data (PPD) at least once in the relevant NMVS is presented per country.

INTRODUCTION (2/2)

























- The **Alert rate** is expressed as a percentage of the total number of scans. This figure includes alert categories A2, A3, A52, A68, A24, A7.
 - < 1% is shown Green
 - >1 % and < 3 % is shown Yellow
 - >3 % is shown Red
- The uploaded **SKUs uploaded** are expressed as an indicative percentage of the total number of SKUs expected to be uploaded in a year
 - Xx is shown Green
 - Xx is shown Yellow
 - Xx is shown Red

The threshold is to be defined and agreed by the Stakeholders. The data will be requested from IQVIA
- The item “**Data provision**” reflects whether the related country provided the information
 - Fully : Green
 - Partially: Yellow
 - Did not provide the data: Red
