We are confident you will find the agenda and topics of your interest and we look forward to receiving a positive response from you soon.

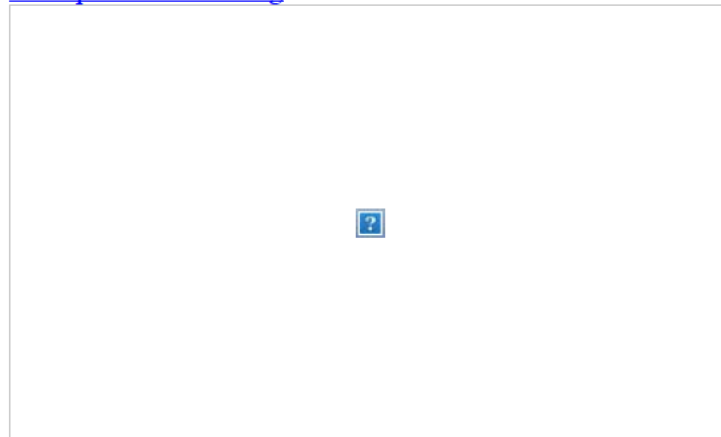

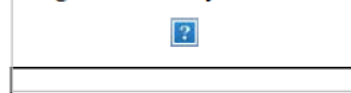

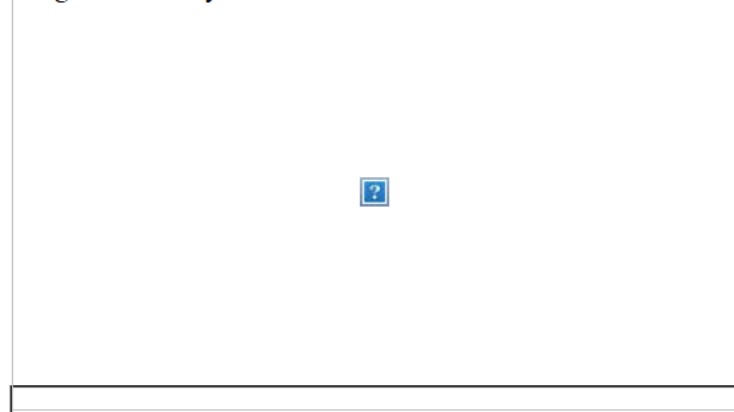
