I hope you are well.

We met in May at the Blue Economy event and follow up dinner organised by Sky EU, where I told you about the work we are doing with our business members to make the business case for stronger environmental regulations and increasing ambition on climate change and the circular economy. I just wanted to let you know that I will be in

Brussels for the IEEP Think 2030 conference, where I will be presenting our paper for the conference on how the EU can increase its ambition on the circular economy and climate change, whilst strengthening the competitiveness of its economy (at 2.30 on Wednesday 17th October).

It would be great to meet whilst I'm in Brussels – we discussed in particular the possibility of Aldersgate Group organising a business-backed event to look at the achievements of this Commission on areas such as the circular economy and debate what should be the priorities for the next Commission to continue work on this agenda. If that's still of interest, it would be good to talk about how we could go about this in more detail. I will be in Brussels from late afternoon on Tuesday 16th October to early afternoon on Thursday 18th October – if you are attending the conference, we could meet there or around it.

I look forward to hearing from you and in the meantime, I have attached for your information the latest policy briefing we have put together to influence the upcoming UK Resources and Waste Strategy which is due by the end of the year.

I hope you are well.

It was a pleasure to meet on Wednesday. As discussed, I would be very

pleased to stay in touch to support upcoming initiatives on the economic value of environmental regulations and the next steps for EU policy on the circular economy package. In particular, we would be very happy to help organise a business-backed event in the autumn / winter to reiterate the business case for regulatory measures to help the EU move towards a more circular economy, discuss the progress delivered by the Commission and debate what EU institutions should focus on to build on this progress in the years to come. Our members come from all across the economy and have a turnover of around €600bn so we could put some very influential businesses on the panel and organise an influential discussion with Vice President Timmermans and potentially the Katainen / Vella cabinets as well?

For your information, the link to our recent Circular Economy Package is [here](#) and I also wanted to share with you the link to a recent report we commissioned from global engineering consultancy BuroHappold on the economic benefits of well-designed environmental regulations ([here](#)), which I think you will find very helpful. In this report, BuroHappold carried out business interviews to understand the economic impacts of three ambitious environmental regulations in the construction (London Plan), waste (Landfill Tax) and automotive industries (EU passenger car emission regulations). In all three cases, the analysis found that the upfront costs of complying with these regulations were outweighed by the economic benefits they triggered through increased business investment in innovation and skills, better quality products and infrastructure, greater business competitiveness and job creation.

I hope this is helpful and I look forward to staying in touch.
