Dear Mr Civillini,

We refer to your e-mail of 5 March 2020, in which you make a request for access to documents, registered on the same day under the abovementioned reference number.

In this e-mail, you requested access to documents relating to 'all meetings (...) and all correspondence (...), for the period between 30 May 2018 to date, between the Secretariat-General, including any member of the Cabinet of Executive Vice-President Frans Timmermans, and registered lobby groups/individuals/associations on the topics of "single-use plastics" and "circular economy".

We have identified 134 documents as falling within the scope of your request. You will find these documents attached to this letter.

Please note that some of the documents are redacted, because they contain personal data¹. The disclosure of such personal data is prevented by Article 4(1)(b) of Regulation (EC) No 1049/2001². The Data Protection Regulation³ also prevents the transmission of personal

Please also note that documents originating from third parties are disclosed to you, based on Regulation (EC) No 1049/2001. However, this disclosure is without prejudice to the rules on intellectual property, which may limit your right to reproduce or exploit the released documents without the agreement of the originator, who may hold an intellectual property right on them. The European Commission does not assume any responsibility from their reuse.
