I would like to thank you again very much for giving us the opportunity to exchange on the future of the solar industry, and its contribution to a Green economic recovery and the European Green Deal at large.

We will follow-up very shortly to bring forward two of the projects we mentioned (feel free to comment if we are missing something):

- **Working meeting with representatives of innovative EU manufacturers of cutting-edge solar technologies and EU market leaders of innovative solar business models (AgriPV, floating solar)** – For your notice, one of our highly-innovative manufacturer Meyer burger will attend a meeting with Commissioner Thierry Breton on 04/05, to discuss this important topic.
- **Working meeting on innovative start-ups and business models for the financing of solar rooftop installations on the building segment.**
- **Collaboration ahead of EU Energy week in June**

In the meantime you will find enclosed the **presentation of our 2050 study and related policy recommendations**, and I also take the opportunity to share the **recommendations on the EU Green recovery** which were sent yesterday to the representatives of EU member States. You will find in this document a strong echo to the elements we have discussed during our call.

Finally, I would like to follow-up on a past email regarding the organization of a **CEO meeting with Commissioner Kadri Simon**. We have seen that successful exchanges were organized with

other EU associations such as Eurelectric, Wind Europe and Hydrogen Europe and would very much welcome the opportunity to gather key CEO's from the EU Solar sector, to discuss the key priorities of our industry in the next year. I attach for your information a **document summing-up our key asks and KPI's for 2020** and would very much appreciate your feedback on how/if/when we could organize such a meeting in the near future. It would certainly send a strong signal to our industry and members.
