Subject: Your application for access to documents – Ref GestDem No 2020/4417

Dear Ms Gerebizza,

We refer to your e-mail dated 17 July 2020 in which you make a request for access to documents, registered on 20 July 2020 under the above-mentioned reference number.

You requested access to:

- i. "All correspondence (including email) between 1st December 2018 and 12 July 2020 between Commissioner Timmermans and/or his cabinets and/or officials from the DG Clima on one hand and representatives from IOGP, Shell, the Global CCS Institute, Hydrogen Europe, Snam and Fleishman Hillard, in which the issue of hydrogen and or carbon capture and storage (CCS) were addressed.
- ii. List of meetings between 1st December 2018 and 12 July 2020 between officials and representatives of DG Clima on one hand and representatives from IOGP, Shell, the Global CCS Institute, Hydrogen Europe, Snam and Fleishman Hillard on the other, in which issue of hydrogen and or carbon capture and storage (CCS) were addressed.
- iii. Minutes of the meetings mentioned above".

We have identified 46 documents that fall under the scope of your application. The list of identified documents is enclosed with this letter.

In accordance with Article 4(4) of Regulation (EC) 1049/2001, DG CLIMA has consulted those third parties concerning the disclosure of the requested documents emanating from them.

Please find the identified documents enclosed with this letter. However, I regret to inform you that I cannot give you access to some parts of documents 1-43.

A complete disclosure of document 1-43 is prevented by the exception concerning the protection of privacy and the integrity of the individual outlined in Article 4(1)(b) of Regulation (EC) No 1049/2001, because they contain: names and contact information of Commission staff members not pertaining to the senior management; names and contact details of other natural persons; other information relating to an identified or identifiable natural person.

Article 9(1)(b) of the Data Protection Regulation does not allow the transmission of these personal data, except if you prove that it is necessary to have the data transmitted to you for a specific purpose in the public interest and where there is no reason to assume that the legitimate interests of the data subject might be prejudiced. In your request, you do not express any particular interest to have access to these personal data nor do you put forward any arguments to establish the necessity to have the data transmitted for a specific purpose in the public interest.

Consequently, I conclude that, pursuant to Article 4(1)(b) of Regulation (EC) No 1049/2001, access cannot be granted to the personal data contained in the requested documents, as the need to obtain access thereto for a purpose in the public interest has not been substantiated and there is no reason to think that the legitimate interests of the individuals concerned would not be prejudiced by disclosure of the personal data concerned.
