Dear Mr Assion,

We refer to your request for access to documents introduced via the Register of Commission Documents on 20/07/2020 and registered, after you provided your postal address, on 07/09/2020 under the above mentioned reference number.

In your application, you requested access to a document which '[...] was mentioned in a Note of the Presidency to Delegations that was part of the trilogue negotiations on the EU Electronic Communications Code (EECC - 2016/0288 (COD)). This Note is dated 24 November 2017 and has the reference number "14670/17". The subject of the Note is "Proposal for a Directive of the European Parliament and of the Council establishing the European Electronic Communications Code (Recast) - Preparation for the trilogue". I obtained this Note through an earlier access request.

This Note, in paragraph 30, mentions a "joint examination" of the Parliament's position" on "the scope of the General Authorisation", also with regard to the intention of the Parliament "to set up a one-stop-shop for general authorisation and extend the scope to number-independent communication services". At the time of the note, this examination was still being prepared.

I hereby request access to the final version of this examination. I assume that it is a memorandum or other summary of the legal findings. [...]'

We regret to inform you that the Commission does not hold any document that would correspond to the description given in your application.
