The EUGINE President Hermann Kröger, Vice-President Kari Hietanen and [REDACTED] would like to thank you very much for the interesting and useful exchange of views we had on Monday on the role of gas engines for climate neutrality, energy system integration as well as in the taxonomy of sustainable economic activities. As agreed, please find enclosed the slides we presented during this meeting.

Following our discussion, we would be grateful if you could:

- **Ask DG Energy to include “gas engines” in all technology-related work the DG is undertaking**
e.g. “technology assumptions” that [REDACTED] is preparing within DG ENER A4 or for future work on energy system integration and hydrogen
- **Make “renewable gas-ready” gas power plants eligible for all relevant EU funding programmes**
e.g. by supporting Member States and MEPs willing to open the scope of the Just Transition Fund to gas power plants allowing a quick coal-to-gas switch and which are compatible with renewable gases
- **Ask DG FISMA to consider the inclusion of gas power generation as “transition activity” in the taxonomy of sustainable economic activities**
please find enclosed our concrete, pragmatic and balanced proposal for doing so.

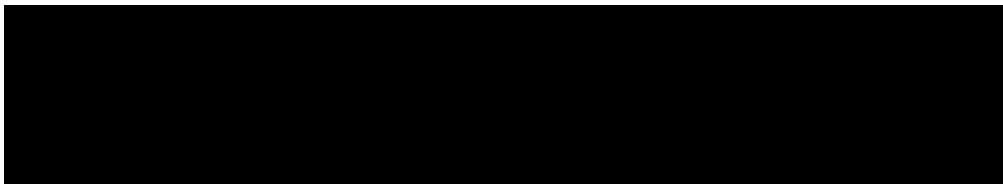
