#### Subject: Your application for access to documents – Ref GestDem No 2020/6470

We refer to your e-mail dated 27 October 2020, in which you make a request for access to documents, registered under the above-mentioned reference number.

Between David Boublil, Cabinet member of Pierre Moscovici and Arcelor Mittal on the 16th July 2019".

Following your request we have identified following documents:

- 2. mail from ArcelorMittal to the Commission dated 23 May 2019;
- 3. Border Adjustment Proposals GIDE/NCTM (attachment to mail 3/7/2019);
- 4. Eurofer Paper State Aid Guidelines (attachment to mail 23/5/2019);
- 5. NERA Steel Indirect CO2 costs Executive Summary (attachment to mail 23/5/2019);
- 6. NERA Steel Indirect CO2 costs (attachment to mail 23/5/2019).

Your application has been dealt with in accordance with Regulation 1049/2001 on public access to Commission documents. In accordance with Article 4(4) of the Regulation, the

third party (ArcelorMittal) was consulted as concerns the e-mails and documents originating from them. In particular, they have been consulted because personal data of their representatives and staff is mentioned in some of the documents.

# Documents 1 to 5

Following from Regulation (EC) No 1049/2001 and based on the consultation with ArcelorMittal, we have considered that documents 1 to 5 can be disclosed. Some references to persons' names and other personal data have been redacted (see below under Personal data). Note that documents 4 and 5 are also publicly available on the website of Eurofer.

# Document 6

Following an examination of the document, and based on the consultation with ArcelorMittal, I regret to inform you that access <u>cannot</u> be granted. The document is an analysis prepared by NERA (economic consulting) exclusively for Eurofer.
