My name is [REDACTED], and I am the Policy Director at FIA Region I.

You have been in contact with my former colleague [REDACTED] in the past; she has left our organisation a few weeks back to pursue other professional aims, and I wanted to take this opportunity to introduce myself and indicate that I will take over the contacts with the cabinet from now on.

As you know, we have been trying to find an opportunity for an interaction with Commissioner Valean, but the crisis triggered by the COVID-19 pandemic, and the lockdown that ensued, have forced us to consecutively cancel several planned events, as it was the case with the Summer Cocktail that was foreseen to take place on June 10 and for which we were considering the possibility of having the Commissioner as our guest speaker.

Meanwhile, we have identified another opportunity and would like to know how you feel about it.

On November 5, a meeting of our Board will be held in Brussels and we would be very eager to have Commissioner Valean joining at some point during that day and having an exchange with our Board members about the main topics of mutual interest.

I know that, unfortunately, it is probably still unclear what the situation will look like in the beginning of November. But we trust that such meeting will be possible to hold as a physical meeting, as we are fortunate enough to have a meeting room big enough to allow, if needed, all the safety measures including social distancing.

Please let me know what you think about this idea, and whether we can proceed with sending an official invitation for the Commissioner.
