Subject: Your application for access to documents about private sector lobbies

We refer to your e-mail dated 20/02/2012 in which you make a request for access to documents.

Your application concerns a very large number of documents, which need to be assessed individually. Such a detailed analysis cannot be carried out within the normal time limits set out in Article 7 of Regulation 1049/2001. However, the Regulation also provides for a possibility to confer with applicants in order to find a fair solution when an application concerns a very large number of documents. Article 6(3) provides that "in the event of an application relating to a very long document or to very large number of documents, the institution concerned may confer with the applicant informally, with a view to finding a fair solution".

Based on this provision, we would kindly ask you whether you could narrow down the scope of your request or be more specific on the files you are interested in, so as to reduce it to a more manageable amount of documents.

We refer to your e-mail dated 20/02/2012 in which you make a request for access to documents.

Your application concerns the following documents:

• All correspondence and minutes of meetings between European Commissioner Olli Rehn, his cabinet and DG ECFIN staff and private sector companies and lobby groups since January 1st 2011 (including meetings that took place in the context of the Troika' of which the European Commission is part (together with the IMf and the ECB) on issues related to Greece, Portugal and Ireland.

Having examined the documents requested under the provisions of Regulation (EC) No 1049/2001 regarding public access to documents, I have come to the conclusion that they may be partially disclosed.
