We refer to your e-mail of 18 January 2021 in which you make a request for access to documents, registered on 20 January 2021 under the above mentioned reference number.

We consider your request to cover documents held up to the date of your initial application, i.e. 18 January 2021.

Please note that due to the wide scope of your request, covering also areas falling under the responsibility of other services, parts of your request have been attributed to Secretariat-General ¹. This reply relates only to the documents held by Directorate-General for Justice and Consumers.

We regret to inform you that the Commission does not hold any documents that would correspond to the description given in your application.
