The discussion during the meeting were about the following topics

Updated Industry Strategy

Business Europe indicated that their members are eager to contribute to the Package. They are preparing a contribution paper to be circulated by end of January or early February, covering the following areas: lessons learnt from the Covid crisis, the green and digital transition, competition and trade-related matters, the Single Market and governance. They also welcome the ecosystem approach.

Replying to questions, the Commission indicated that the Package is expected to be adopted before the Spring Council meeting; the SME angle will be very much embedded in the Package, including an update of the SME strategy; an analysis of the strategic capacities/dependencies will also be included, as requested by the Council; alliances are considered to be key for the development of some sectors.

Business Europe highlighted their generally positive approach to the EU taxonomy (i.e. they support the overall regulation). However, they indicated that the industry is concerned with the delegated act on climate, in particular on the feasibility of its implementation.

Industry Forum

Business Europe has applied for the Industry Forum, via a Finish company which is specialised on international industry businesses.

The Commission mentioned the timeline for selection of applications, as well as the possible date of the Forum.

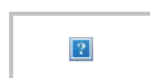
