They seem to be the only country using v1.2.1 right now for the emission of DCCs and it would be very important to know if we need to prioritize v1.2.1 or not. Are their representatives attending the eHN organizational and technical meetings? Can you talk to Switzerland or give us some persons there to contact them directly from Spain?

Dear all,

We have been talking in several meetings about creating a list of JSON Schema versions used by all MS while emitting DCCs.

The JSON Schema v1.3.0 implementation was published 10 hours ago:
<https://github.com/ehn-dcc-development/ehn-dcc-schema/releases/tag/1.3.0>

We are facing significant challenges implementing all possible JSON schema versions at the verifier side and really need to prioritize the development schedule.

Right now we have the following versions:

1.3.0
1.2.1
1.2.0
1.1.0
1.0.1
1.0.0

Most MS are using JSON Schema v1.0.0 right now for the emission of DCC.
New MS going live are supposed to use JSON Schema v1.3.0 in emission.

So, the question is: has any MS used, or is any MS planning to use the intermediate versions, i.e. v1.0.1, v1.1.0, v1.2.0 or v1.2.1?

Also, regarding version 1.3.0, which is the earliest date wherein we need to be able to verify it? Is Luxembourg using it since the 13th of June? Is any other MS going live with version 1.3.0 before the 1st of July?
