Subject: Your access to document request GESTDEM 2021-7979

Dear Mr Sabido,

I refer to your request of 08 December 2021 for access to Commission documents, registered the same day under the above-mentioned reference number.

You request access to:

- a list of all meetings held from 1 July 2021 on the topic of the "Hydrogen and decarbonised gas package" between DG Energy and any of the following stakeholders: FTI Consulting, ENTSO-G, Zero Emissions Platform and/or the Global CCS Institute;

- minutes of all said meetings held from 1 July 2021 on the topic of the "Hydrogen and decarbonised gas package" between DG Energy and any of the following stakeholders: FTI Consulting, ENTSO-G, Zero Emissions Platform and/or the Global CCS Institute;

- all correspondence from 1 July 2021 on the topic of the "Hydrogen and decarbonised gas package" between DG Energy and any of the following stakeholders: FTI Consulting, ENTSO-G, Zero Emissions Platform and/or the Global CCS Institute;

Following an examination of the documents requested under the provisions of Regulation (EC) No 1049/2001 regarding public access to documents, we have identified **two** documents related to the meeting I had with representatives of **Zero Emissions Platform** on 02.12.2021 as falling in the scope of your request.

Concerning the letter of **Zero Emissions Platform**, dated 11.10.2021, since it originates from third parties, the originators of the document have been consulted and they did not oppose to their disclosure with personal data expunged.

I am glad to inform you that all identified documents can be disclosed, subject only to the redaction of personal data.

In this respect, some parts of the documents have been blanked out as their disclosure is prevented by exceptions to the right of access laid down in Article 4 paragraph 1(b) of Regulation (EC) No 1049/2001 because they contain the personal data.

Pursuant to Article 4(1)(b) of Regulation (EC) No 1049/2001, access to a document has to be refused if its disclosure would undermine the protection of privacy and the integrity of the individual, in particular in accordance with European Union legislation regarding the protection of personal data.

Article 9(1)(b) of the Data Protection Regulation¹ does not allow the transmission of these personal data, except if you prove that it is necessary to have the data transmitted to you for a specific purpose in the public interest and where there is no reason to assume that the legitimate interests of the data subject might be prejudiced. In your request, you do not express any particular interest to have access to these personal data nor do you put forward any arguments to establish the necessity to have the data transmitted for a specific purpose in the public interest.

Consequently, I conclude that, pursuant to Article 4(1)(b) of Regulation (EC) No 1049/2001, access cannot be granted to the personal data contained in the requested documents, with exception for names of main representatives, as the need to obtain access thereto for a purpose in the public interest has not been substantiated and there is no reason to think that the legitimate interests of the individuals concerned would not be prejudiced by disclosure of the personal data concerned.

Please note that the documents originating from third parties are disclosed to you based on Regulation (EC) No 1049/2001. However, this disclosure is without prejudice to the rules on intellectual property, which may limit your right to reproduce or exploit the released documents without the agreement of the originator, who may hold an intellectual property right on them. The European Commission does not assume any responsibility from their reuse.

Please find enclosed the redacted copies of the documents in question.

As regards the other stakeholders listed in your request (**FTI Consulting, ENTSO-G and the Global CCS Institute**), I regret to inform you that no documents had been found. Indeed, as specified in Article 2(3) of Regulation 1049/2001, the right of access as defined in that regulation applies only to existing documents in the possession of the institution.

Concerning point 1 of your request "list of meetings", I would like to inform you that the Commission does not hold lists of meetings for officials below Director-General level.
