Subject: Your application for access to documents – GESTDEM 2022/0692

We refer to your request for access to documents on 28 January 2022, registered under the above-mentioned reference number on 1 February 2022.

You request access to:

“Detailed minutes of the exchange between cabinet members of EVP Vestager, Werner Stengg and Christiane Canenbley, and representatives from Google during their meeting on December 2 2022. Should detailed minutes be unavailable I would ask that a written summary of the meeting be made available.

All correspondence (i.e. any emails, correspondence, telephone call notes, and/or text messages including WhatsApp exchanges) between the Cabinet Offices of EVP Vestager and Google conducted either prior to the meeting or subsequent to it.”.

We have identified the following documents responsive to your request:

- 1. E-mail exchange leading to the 2 December 2021 meeting*
- 2. Minutes of the 2 December 2021 meeting between the Cabinet of EVP Vestager and Google representatives*
- 3. Follow-up letter from Google*
- 4. A follow-up e-mail from Google transmitting the follow-up letter*

Full disclosure of the identified documents as listed above is prevented by the exception concerning the protection of privacy and the integrity of the individual outlined in Article 4(1)(b) of Regulation (EC) No 1049/2001, because they contain personal data.

Article 9(1)(b) of the Data Protection Regulation (Regulation 2018/1725) does not allow the transmission of these personal data, except if you prove that it is necessary to have the data transmitted to you for a specific purpose in the public interest and where there is no reason to assume that the legitimate interests of the data subject might be prejudiced. In your request, you do neither express any particular interest to have access to these personal data, nor put forward arguments to establish the necessity to have the data transmitted for a specific purpose in the public interest.

The minutes of the meeting were drawn up for internal use under the responsibility of their author. The document solely reflects the author's interpretation of the interventions made and does not set out any official position of the third party to which it refers, which was not consulted on its content. It does not reflect the position of the Commission and cannot be quoted as such.

Moreover, some parts of the document under point 3 have been blanked out as their disclosure is prevented by the exception to the right of access laid down in Article 4(2) of Regulation (EC) No 1049/2001. The disclosure of these parts would undermine the protection of the company's commercial interests as they relate to commercially sensitive business information.

In case you would disagree with this position, you are entitled, in accordance with Article 7(2) of Regulation (EC) No 1049/2001, to submit a confirmatory application requesting the Commission to review this position.

Such a confirmatory application should be addressed within 15 working days upon receipt of this letter to the Secretariat-General of the Commission at the following address:
