On 26 January, the Volvo Cars public affairs team will be gathered in Brussels for a series of meetings and discussions around the future of transport, electrification, sustainability and more. Volvo Cars is taking decisive action to become climate neutral by 2040, including by stopping the production of all its ICE cars in 2030 globally. We also recently signed the zero emission road transport declaration at COP26 and introduced an internal carbon price of 1,000 SEK (~100 EUR) for every tonne of carbon emissions from across our entire business to reduce emissions all along our supply chains.

With this in mind, we would be delighted if you have the possibility to meet with us on 26 January to discuss how European policies (CO2 regulation, AFIR etc.) can enable and accelerate the greening of the auto industry, and how we as an OEM can support the European Commission in this important endeavor.
