First of all, let me thank you for the welcoming video of Ms. Simson provided at the Annual Event of Gas Infrastructure Europe (GIE) in Luzern. Our industry received very well the messages of the Commissioner, which was tackling completely the transition elements we are all working in.

Based on that and the upcoming legislative development we would like to suggest having a meeting between Ms. Simson and Mr. Brabo, the GIE President, and to exchange on the following:

- **Hydrogen and Decarbonised Gas Package:** Gas Infrastructure Operators are ready to integrate renewable and low-carbon gases into their systems, especially hydrogen. They can follow different pathways (e.g. local clusters, dedicated hydrogen infrastructure, blending) and adapt to different national specificities. Our systems provide the opportunity to cost-efficiently transport hydrogen over long-distances, to provide long-term storage of renewable energy and to enable imports and exports of hydrogen carriers. - **Fit-for 55 Package:** GIE supports the Commission's proposals under the Fit-for 55 package. GIE is working to facilitate the injection of renewable and low-carbon gases into our infrastructure systems and thereby, contributing to the targets laid out in the EU Green Deal. - **Current high energy prices:** GIE believes that our existing gas infrastructure, especially its flexibility for long-term energy storage, is a valuable asset both in the short- and long-term to maintain energy prices at affordable levels, reduce the risk of energy poverty and guarantee the social acceptance of the energy transition. Regional specificities can be observed and its benefits should be exploited.
