- **User-friendly EU27 mapping of all data**

We would like to highlight the following **disclaimers**:

1. All data is based on the current scheduling. The scheduling might be subject to changes, if further opportunities arise.
2. These are all primary capacities. There could be potential slot availabilities on the secondary market on which operators only have short term visibility.
3. This information is commercially sensitive. It should not be published or tweeted.

If you find it useful, we would like to propose a short meeting at your convenience to offer an interpretation of the raw data.

To enable a quick response to your inquiry on LNG Terminal available capacities, allow us to already provide you with **the most recent data snapshot taken from our ALSI Transparency Platform** at <https://alsi.gie.eu> . The attached file covers **the most recent capacity data status for each European LNG terminal**, as received **this morning, 3 February at 08:45am**.

As the data on ALSI is based on REMIT reporting, we are able to expand the reported datasets with Contracted and Available Capacities, highlighted for each terminal. Data definitions are inserted in a separate worksheet. Please take into account that commercial capacities (contracted/available) are only available on an aggregated level for Spain (see added footnote).

We have received additional information from our LNG Terminal Operators and will further complete this with additional information and forecasts. We will send it to you as soon as ready.

We will collect information on the (i) Commercial availability/terminal and the (ii) Physical availability/terminal **and revert to you in the next 48 hours**. Please let us know if anything else is needed, in copy, I put as well my colleague [REDACTED] that is responsible for LNG within GIE (GLE).

We confirm as well the publication of the picture. If there is a possibility to link the data on the slide to the [AGSI+ platform](#) as a source, that will be great. This is as we did the slide quickly yesterday to showcase the situation in Europe, so not all storages are well seen. We rely on you on what is feasible. Thank you!
