Thank you for the nice telephone conversation this morning. As already said, I am from the International Association of Mutual Benefit Societies (AIM), an umbrella organisation of federations of health mutuals and health insurance bodies counting with 55 members from 28 countries around Europe, Latin America and Africa and the Middle East. AIM members are all not-for-profit organisations providing health coverage to around 240 million people, as well as services relating to compulsory and/or supplementary health insurance, some of them also managing health and social insurance services. Our members are either mutuals or health insurance funds. They rely on no shareholders: all surpluses are used to benefit their members and they comply with the principle of solidarity between members.

I am looking for a responsible person within the cabinet of Commissioner Kyriakides to have an exchange on the European Health Data Space. Our members have a lot of health data and welcome the plans on the European Health Data Space but are, at the same time, worried about the safety of the exchange.
