Dear Sir,

We refer to your application dated 22 March 2022 in which you make a request for access to documents, registered on 24 March 2022 under the abovementioned reference number.

You request access to documents which contain the following information:

“Any appeals by the EU commission to international partners concerning the adoption of sanctions against Russian persons and entities regarding the blockage of airspace. Any transcripts of meetings with partners and foreign states concerning the aviation policy regarding Russia. (e.g. San Marino, Albania, North Macedonia, Switzerland, Isle of Man). Any electronic communication on the same matter”.

Having examined your request under the provisions of Regulation (EC) No 1049/2001 regarding public access to European Parliament, Council and Commission documents¹ (hereinafter ‘Regulation (EC) No 1049/2001’), we regret to inform you that your application cannot be granted, as the disclosure of the documents concerned is prevented by exceptions to the right of access laid down in Article 4(1)(a) of this Regulation.


