73 cases - we wrongly attributed and reviewed following the monitoring and removed.

Of the 48 notifications wrongly attributed by the NGOs we have only had confirmation back from 1 (ROMEA) so far. I will update this thread when we have more bulk numbers

Thanks, would you plan to make further analysis on the remaining cases or you stick to the sample? Are the 73 cases of notifications that the NGOs wrongly encoded as not actioned but that in fact were? Or is it n. of cases on which you did not consider the content to be illegal hate speech?

If it is a case of possible wrong encoding, happy to make modifications if NGOs agree. Perhaps you could insist for a feedback by the ones with bigger numbers like In Iustitia and Khetane?

And, if you have figures of divergent assessments (n. of cases where you disagreed about the flag with the NGOs) let me know and we are happy to include these in the factsheet.

Hi

So our teams didnt have enough time to go through all the reports, so we cut it down to a sample (435 of 1252 reports). From this sample we were able to find the follow stats:

- We actioned an additional **73 cases** as part of our analysis (chart below)
- 48 of reports we examined had a notification sent where the NGO indicated otherwise. (bottom of email)

We are still awaiting feedback from the NGOs to determine where the notifications ended up, but it is taking much more time.

For the statement, I will have something to you by tomorrow if that is ok.
